13	SECTION 1. NEW LAW A new section of law to be codified
14	in the Oklahoma Statutes as Section 1-9-343 of Title 12A, unless
15	there is created a duplication in numbering, reads as follows:
16	(a) A security interest that is enforceable and perfected
17	immediately before the effective date of this act is a perfected
18	security interest under this act if, on the effective date of this
19	act, the requirements for enforceability and perfection under this
20	act are satisfied without further action.
21	(b) If a security interest is enforceable and perfected
22	immediately before the effective date of this act, but the
23	requirements for enforceability or perfection under this act are not
24 27	satisfied on the effective date of this act, the security interest:

(1) Is a perfected security interest until the earlier of the time perfection would have ceased under the law in effect immediately before the effective date of this act or the adjustment date;

8 (3) Remains perfected thereafter only if the requirements for

SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1-9-343.1 of Title 12A, unless there is created a duplication in numbering, reads as follows:

A security interest that is enforceable immediately before the effective date of this act, but is unperfected at that time:

16 (1) Remains an enforceable security interest until the 17 adjustment date;

18 (2) Remains enforceable thereafter if the security interest 19 becomes enforceable under Section 9-203, as amended by this act, on 20 the effective date of this act or before the adjustment date; and 21 (3) Becomes perfected:

(A) without further action, on the effective date of this act if the requirements for perfection under this act are satisfied before or at that time, or
