7	A Joint Resolution directing the Secretary of State to refer to the people for their approval or
8 9	rejection proposed amendments to Sections 1 and 23 of Article VI of the Oklahoma Constitution, which relate to executive officers; making language gender
10	neutral; directing the Governor to appoint the Insurance Commissioner; providing procedures;
11	requiring consent of the Senate; removing term limit provisions; updating language; providing ballot
12	title; and directing filing.

14	BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
15	1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:
16	SECTION 1. The Secretary of State shall refer to the people for
17	their approval or rejection, as and in the manner provided by law,
18	the following proposed amendments to Sections 1 and 23 of Article VI
19	of the Oklahoma Constitution to read as follows:
20	Section 1. A. The Executive authority of the state shall be
21	vested in a Governor, Lieutenant Governor, Secretary of State, State
22	Auditor and Inspector, Attorney General, State Treasurer,
23	Superintendent of Public Instruction, Commissioner of Labor,
24 47	<u>Insurance</u> Commissioner of Insurance, and other officers provided by

¹ law and this Constitution, each of whom shall keep his <u>or her</u> office ² and public records, books, and papers at the seat of government, and ³ shall perform such duties as may be designated in this Constitution ⁴ or prescribed by law.

⁵ B. The Secretary of State shall be appointed by the Governor by
⁶ and with the consent of the Senate for a term of four (4) years to
⁷ run concurrently with the term of the Governor.

⁸ <u>C. Upon expiration of the term of the Insurance Commissioner</u>
⁹ <u>elected in 2026, the Insurance Commissioner shall be appointed by</u>
¹⁰ <u>the Governor by and with the consent of the Senate and shall serve</u>
¹¹ at the pleasure of the Governor.

12 Section 23. A. There shall be elected by the qualified 13 electors of the State, at the first general election, a chief 14 officer of the Insurance Department, who shall be styled the 15 "Insurance Commissioner", whose term of office shall be four years: 16 Provided, That the first term of the Insurance Commissioner so 17 elected, shall expire at the time of the expiration of the term of 18 office of the first Governor elected The Insurance Commissioner 19 shall be appointed by the Governor by and with the consent of the 20 Senate as provided in Section 1 of this article. The Insurance 21 Commissioner shall be at least twenty-five (25) years of age and 22 well versed in insurance matters.

²³ B. No person shall be eligible to serve as Insurance
²⁴ Commissioner for a period of time in excess of eight (8) years.
